Friday, July 27, 10am-5pm: **Bring artwork to the Bozeman Public Library Conference Room**  
Wednesday, August 1: **Art show begins**  
Friday, August 24: **Art show ends**  
Saturday, August 25, 10am-5pm: **Pick up exhibited artwork in the Bozeman Public Library atrium**

### ***ALL HANGING TWO-DIMENSIONAL & THREE-DIMENSIONAL JURIED SHOW:***

**ENTRY FEE: \$10** paid by cash or check payable to Sweet Pea Festival.

### **RIBBONS AND CASH PRIZES:**

- **Representational/Realistic Art:** First Place – \$50.00, Second Place – \$40.00, Third Place – \$30.00, Fourth Place – \$20.00, and Honorable Mention – \$10.00.
- **3-D (sculptural/relief) & Abstract/Non-Objective Art:** First Place – \$50.00, Second Place – \$40.00, Third Place – \$30.00, Fourth Place – \$20.00, and Honorable Mention – \$10.00.
- **Best of Show:** Grand Prize – \$100.00.

**Limited entries accepted:** The number of pieces juried into the show will be determined by wall-hanging space. Artists whose work has not been selected will be notified after 5pm, Saturday, July 28<sup>th</sup> by phone/email. Artwork and refund of entry fee must be picked up at the Conference Room of the library between 5pm-7pm, on Monday, July 30<sup>th</sup>.

### ***ELIGIBILITY:***

**Only ONE ORIGINAL entry per applicant in any medium:** Artwork must be \*one-of-a-kind\* and not a copy or reproduction of the original. Photographic prints must be made from artist's original negative or digital file that has been processed by the artist or under his/her direct supervision. Photographers are required to disclose their creative process and printing process. No 3-D free-standing work will be accepted.

**Recent artwork:** Created within the last THREE YEARS and not previously shown at the Bozeman Public Library.

**Hanging 2-D & 3-D size cannot exceed:** 3 ft. x 4ft. (36" x 48") or 12 sq ft.

**Professional hanging quality:** Framed/Staple-free edge (canvas), or sculptural forms not designed for frames, must be excellently finished off with wire or D-rings that will hang on a cable ratchet hook. Written instructions must accompany unusual installations. Heavy artwork must be designed for two cable wires/hooks.

**Hand delivery of work to the library:** Artwork must be delivered **properly labeled** with the **entry form** and non-refundable **\$10 fee**. Entry fee will only be refunded to artists not juried into the show.

#### ***NON-MANDATORY SALES:***

**Sales procedure:** The artist will sell their own artwork and appoint someone else if not planning to be in the area. In addition, the following is expected of the artist:

- Explain to the buyer that **ALL ARTWORK MUST REMAIN UNTIL THE END OF THE SHOW.**
- Cover all costs and responsibility to pack, handle, and ship artwork to the buyer's requested address.
- Write "SOLD" on the price card next to displayed artwork.

#### ***OTHER TERMS & REQUIREMENTS:***

**Right of refusal:** Artwork upon delivery that conflicts with the standards set forth by the Sweet Pea Festival and library (i.e. not child friendly – violence and nudity), as well as, artwork not able to be exhibited in a safe, practical manner, will not be accepted. Please keep in mind that the artwork will be located in an area heavily frequented by the public and will not be monitored by security.

**Insurance:** Limited nominal insurance is provided for artwork and exhibitors are expected to provide additional insurance if desired. Neither the Sweet Pea Festival nor the Bozeman Public Library is responsible for artwork during transit or artwork not picked up by specified dates and times.

**No shipping will be executed:** All entries must be delivered and retrieved by hand.

**Art retrieval:** Artwork not picked up will be charged a \$5.00 per day storage fee at the Sweet Pea Office and will be paid by the artist to the Sweet Pea Festival. After Friday, September 21<sup>st</sup>, the artwork will be disposed of.
