Digital entries are preferred but hand delivered entries will be accepted at the Sweet Pea Office, 424 E. Main St., Suite 203B, Bozeman, MT (the Jacobs Crossing Building, 2nd Floor) during operating hours. Please call 406-586-4003 for weekly schedule prior to stopping by.

Deadline for all hand-delivered entries is 5:00PM Friday, May 3.

Mailed entries should be sent to 424 E. Main St., Suite 203B Bozeman, MT 59715 and must arrive by Friday, May 3 2024. PLEASE DO NOT SEND YOUR ENTRY "SIGNATURE REQUIRED."

All entries must be submitted with an entry form, at the bottom of this announcement.

All entries must be clearly identified (on the reverse side if hand delivered) with the attached entry form. Additionally, the 18" x 24" entry must be mounted on a firm back (foam core) or within a frame. The Sweet Pea Board of Directors reserves the rights to reject any and all entries, to request one design change from the winner should the Board determine it necessary, and reserves the final say regarding application of elements in Option #2 (see Entry Specifications below). Sweet Pea Festival and its officers and agents are not responsible for the loss or damage to entries or frames, although reasonable care will be taken to insure that all entries are safely handled and displayed.

Everyone is eligible to enter the poster contest. There is no age limit for contestants. All ages and levels of expertise are encouraged to enter.

Image size of entry must be 18" x 24" vertical or horizontal. Entries in dimensions other than these WILL NOT be considered. Contestants have two options to choose from for their entry. Art in either option must be finished artwork, framed or ready to be framed. Please be aware that the winning entry cannot feature items such as cigarettes or weapons that are NOT allowed at the Sweet Pea Festival and should not feature items such as dogs or pets.

Contestants have two options to choose from for their entry:

OPTION #1: An illustration in your choice of media, and for those familiar with the usage of type, you may include the words "Sweet Pea '24" OR "Sweet Pea 2024", OR "Sweet Pea's 47th Festival," OR "Sweet Pea - Where Art & Community Meet", the Sweet Pea logo (see above or email ed@sweetpeafestival.org for an electronic version), "August 2, 3, & 4", "Bozeman, Montana", "Sweet Pea, A Festival of the Arts", "©2024", as elements in your artwork.

OPTION #2: An illustration in your choice of media excluding the type in Option #1. The artwork does not need to have a reserved space for the type. The Sweet Pea Graphics Committee will apply those type elements. Please note: It can be difficult for the judges to envision the added type.

Entrant agrees that the Sweet Pea Festival shall own all entries that incorporate the Sweet Pea name, logo, design, or any reference to the Sweet Pea Festival and the copyrights for these entries. Sweet Pea Festival is given the right to adjust the winning entry to other graphic materials without further compensation to the winning entrant.

The Sweet Pea Board of Directors will jury the entries at their regular May meeting. The winning artist will be notified between May 15-31, 2024, and announced on our website and social media after notification. Non-winning artists are not guaranteed to receive notification and will not be provided any feedback on their entry.

Entries may be displayed either on our website or in conjunction with the Festival, the specific time and place to be announced.

If OPTION #1 listed above was used: Sweet Pea Festival will retain all entries in Option 1; however, the entrant of a non-winning entry may request, in writing from the Sweet Pea Festival, reclamation of the artwork of the entry provided that no reproduction shall make any association with the Sweet Pea Festival. Such permission shall not be unreasonably denied. (A standard reclamation form can be provided by Sweet Pea if desired. Artist signature required.) Non-winning, hand-delivered entries may be picked up after September 3, 2024 at the Sweet Pea office in the Jacobs Crossing Building, 424 E. Main St., Suite 203B. Please call or email Sweet pea Festival to confirm office hours prior to pick up.

If OPTION #2 listed above was used: Non-winning, hand-delivered entries without text and/or logo may be picked up **after September 3, 2024** at the Sweet Pea office in the Jacobs Crossing Building, 424 E. Main St., Suite 203B. Please call or email Sweet pea Festival to confirm office hours prior to pick up.

Non-winning, mailed in entries will be returned ONLY if a sturdy reusable container is provided at entry and a check for \$35 is included to cover return postage and handling. (International entries will not be returned.) Entries with appropriate packaging and payment will be shipped after September 16, 2024.

No entries will be stored after September 30, 2024.
